5. To provide students the information pertaining to contact address and telephone numbers of the person(s) identified to receive complaints/distress calls;
6. To offer services of counselling and create awareness among the students
7. To take all necessary measures for prevention of Ragging inside the Campus/ Hostels.
8. To monitor the anti-ragging activities in the institution.
9. To consider the recommendations of the Anti-Ragging Squad and take appropriate decisions, including spelling out suitable punishments to those found guilty.

**Duties**

1. Look into the complaints lodged by any student, and judge its merit.
2. Look into matters of harassment. Anyone with a genuine grievance may approach the Grievance Redressal Committee members in person.
3. The Ombudsman shall exercise his powers to hear any grievance
  - a. of any student against the university or institution affiliated to it or an institute, as the case may be, after the student has availed of remedies available in such institution for redressal of grievance; and
  - b. of any applicant for admission as student to such institution
  - c. The Ombudsman shall have power to seek the assistance of any person belonging to the Scheduled Castes, the Scheduled Tribes, Socially and Economically Backward Classes, minority or disabled category, as amicus curiae, for hearing complaints of alleged discrimination.

**Duties**

- 1) Implementing the policies relating to the prevention of sexual harassment, resolving complaints by the aggrieved and recommending actions to be taken by the employer.
- 2) It is entitled to initiate an inquiry into the complaint of a sexual harassment incident at workplace
- 3) It can summon witnesses and parties before the committee to give statement
- 4) It can assert powers and summon evidence to be examined, if it is deemed necessary to do so by the Committee
- 5) Once the inquiry is completed and if the Internal Complaint Committee finds the person guilty, it is well within its right to prescribe following actions:
  - a) Initiate action against the culprit in accordance with the service rules of the organization.
  - b) In absence of service rules, it can take actions like a warning, community service, withholding promotion, termination, etc.
  - c) It can deduct from the salary of respondent as compensation to be paid to aggrieved women.
